PROPYLENE GLYCOL	The acute oral toxicity of propylene glycol is very low, and large quantilies are required to cause perceptible health damage in humans. Serious toxicity generally occurs only at plasma concentrations over 1 g1, which requires extremely high intake over a relatively short period of time. It would be nearly impossible to reach toxic levels by consuming foods or supplements, which contain at most 1 g/kg of PG. Cases of propylene glycol poisoning are usually related to either inappropriate intravenous administration or accidental ingestion of large quantities by children. The potential for long-term oral toxicity is also low. Because of its low chronic oral toxicity, propylene glycol was classified by the U. S. Food and Drug Administration as "generally recognized as safe" (GRAS) for uses as a direct food additive. Prolonged contact with propylene glycol is essentially non-initiating to the skin. Unditued propylene glycol is minimally initiating to the eye, and can produce sliph transient conjunctivitis (the eye recovers after the exposure is removed). Exposure to misits may cause eye irritation, as well as upper respiratory track irritation. Inhalation of the propylene glycol vapours appears to present no significant hazard in ordinary applications. However, limited human experience indicates that inhalation of propylene glycol imsits could be irritating to some individuals it is therefore recommended that propylene glycol not be used in applications via nultifexes solutions for emerginary eye wash stations. Propylene glycol is metabolised in the human body into pruvice acid (a normal part of the glucose-metabolism process, readily converted to energy), acetic acid (handled by ethanid-metabolism), lactic acid (a normal acid generally abundant during digestion), and propionaldehyde (a potentialhy hazardous substance).
